RESOLUTION DECLARING IT NECESSARY TO LEVY A TAX IN EXCESS OF THE 10 MILL LIMITATION REVISED CODE, SEC. 5705.19, .191, .192, .194, .21, .26, AND DECLARING AN EMERGENCY.

THE VILLAGE OF NEW LEXINGTON MET IN REGULAR SESSION ON THE 18TH DAY OF JULY, 2022, AT THE OFFICE OF 215 S. MAIN STREET, NEW LEXINGTON OHIO 43764 WITH THE FOLLOWING MEMBERS PRESENT:

Jeff Danison MOVED THE ADOPTION OF THE FOLLOWING RESOLUTION:

WHEREAS, THE AMOUNT OF TAXES WHICH MAY BE RAISED WITHIN THE TEN MILL LIMITATION WILL BE INSUFFICIENT TO PROVIDE AN ADEQUATE AMOUNT FOR THE NECESSARY REQUIREMENTS OF THE SAID SUBDIVISION, VILLAGE COUNCIL OF THE VILLAGE OF NEW LEXINGTON, COUNTY OF PERRY;

RESOLVED, BY THE VILLAGE COUNCIL OF THE MEMBERS ELECTED THERETO CONCURRING, THAT IS NECESSARY TO LEVY A TAX IN EXCESS OF THE TEN MILL LIMITATION FOR THE BENEFIT OF THE SAID SUBDIVISION, VILLAGE OF NEW LEXINGTON.

FOR THE **PURPOSE OF MAINTAINING AND OEPRATING THE NEW LEXINGTON POLICE DEPARTMENT**

REVISED CODE NUMBER FOR THE PURPOSE IS 5705.19(J)

AN ADDITIONAL TAX OF SIX MILLS.

AT A RATE NOT EXCEEDING 6 MILLS FOR EACH ONE DOLLAR OF VALUATION, WHICH AMOUNTS TO \$.60 FOR EACH ONE HUNDRED DOLLARS OF VALUATION, FOR CONTINUING AMOUNT OF TIME COMMENCING 2023, FIRST DUE IN CALENDAR YEAR 2024.

RESOLVED, THAT THE FINANCE DIRECTOR BE, AND HEREBY IS, DIRECTED TO CERTIFY A COPY OF THIS RESOLUTION TO THE DIRECTOR OF ELECTIONS, PERRY COUNTY, OHIO, IN ORDER THAT SUITABLE ARRANGEMENTS CAN BE MADE FOR THE SUBMISSION OF SAID QUESTION OF LEVYING TAXES BE SUBMITTED TO THE ELECTORS OF SAID SUBDIVISION AT THE GENERAL ELECTION TO BE HELD AT THE USUAL PLACES WITHIN SAID SUBDIVISION ON THE 8TH DAY OF NOVEMBER, 2022.

ATTACHED IS A COPY OF THE CERTIFICATE OF ESTIMATED PROPERTY TAX REVENUE.

RESOLVED, THAT SAID LEVY BE PLACED UPON THE TAX LIST OF THE CURRENT YEAR AFTER THE FEBRUARY SETTLEMENT NEXT SUCCEEDING THE ELECTION, IF MAJORITY OF THE ELECTORS VOTING THERON VOTE IN FAVOR THEREOF; AND BE IT FURTHER.

RESOLVED, THAT THE FINANCE DIRECTOR OF THE SAID VILLAGE OF NEW LEXINGTON, COUNTY OF PERRY, OHIO NOTIFY THE BOARD OF ELECTIONS TO CAUSE NOTICE OF ELECTION ON THE QUESTION OF LEVYING SAID TAX TO BE GIVEN AS REQUIRED BY LAW.
